The Burt County Board of Supervisors met in regular session on Monday, October 28, 2024 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. <u>Road Maintenance Agreement – Quinnebaugh TWP</u>: Township agrees to pay Burt

County the rate of \$160.00 per hour for regular maintenance and snow removal;

Chairman Connealy signed the agreement.

#### BURT COUNTY SOLAR:

Present speaking: Brian Boerner with Sandhills Energy gave an update on the 250-megawatt project. He stated that they should not need an extension on the current CUP. A power agreement has been secured. Timeline was reported as follows: construction prep -spring 2025; construction anticipated to begin – Fall 2025, after that harvest season; full install schedule anticipated to be completed – late 2026 to early 2027.

#### Closed Session:

Titus made a motion to go into *Closed Session*, Kutchera seconded, and the motion passed with All Ayes. Chairman Connealy declared at 9:24 A.M. the board went into closed session *for the protection of public interest to discuss collective bargaining*. Kutchera made a motion to come out of Closed Session, Pearson seconded, and motion passed with All Ayes. Chairman declared the public meeting back in regular session at 9:57 A.M. No action was taken during closed session.

Collective Bargaining for FOP (Fraternal Order of Police) Lodge #95:

The board approved to authorize Chairman Connealy to sign the agreement with FOP. Upon motions by Pearson and Kutchera, By Roll Call Vote: Ayes- Kutchera, Richards, Pearson, Titus, Schold and Connealy. Nays – Swanson.

## Audit FY 2023-2024 - single audit for ARPA funds:

Chairman Connealy signed the Engagement Letter for the 2023-2024 single Audit of Coronavirus State and Local Fiscal Recovery (ARPA) funds, the compliance examination is being performed by *Contryman Associates P.C.* 

**Burt County Economic Development (BCEDC)** Cindy Chatt, director BCEDC: Chatt provided updates from BCEDC board business; items discussed were grants, tourism campaigns and tourism board members. No action was required by the County Board of Supervisors regarding BCEDC business happenings at this time.

### **Board of Equalization:**

Schold moved the Board recess at 10:38 AM for *Board of Equalization*, Swanson seconded, motion passed All Ayes. The Burt County Board of Supervisors reconvened at 10:53 AM upon motion by Schold, seconded by Titus, All Ayes. See separate minutes for BOE.

PUBLIC COMMENT: Bill Price, 1615 CoRd. 10, Lyons – discussed a case that caused concerns about negative health effects from Wind Turbines.
