The Burt County Board of Supervisors met in regular session on Wednesday, June 11, 2025 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Medicare SHIP Program:

Mary Loftis presented an overview of her services provided during her 2024-2025 contract for Medicare SHIP Programming. Loftis reported the services/contract agreement is working out well, and she will continue to serve all three Counties of Burt, Dodge and Washington. Loftis presented a contract for July 1, 2025-June 30, 2026; contract fees will be assessed to each County as follows: Burt County - \$12,400.00; Dodge County - \$3,100.00; and Washington County - \$3,100.00. The Counties will be billed quarterly. The board agreed the services are very helpful for constituents and the new contract was approved upon motion by Titus, seconded by Richards. By Roll Call Vote: Ayes –Swanson, Kutchera, Titus, Pearson, Johnson, Richards and Connealy. Nays- none.

Board of Equalization:

Richards moved the Board recess at 9:17 AM for *Board of Equalization*, Johnson seconded, motion passed All Ayes. The Burt County Board of Supervisors reconvened at 9:22 AM upon motion by Pearson, seconded by Kutchera, All Ayes. See separate minutes for BOE.

<u>Tool Truck:</u> Following discussion, the board approved to try to procure a vehicle via online auction. 2019 Chevy Silverado 5500 HD 4x4 service Truck with Tiger Mechanic's Boom, with 84,281 miles. It is listed with Big Iron (Mead, NE), auction ends June 18, a couple of road employees will go check it over before the auction end date and report to the road committee if they want to proceed with bidding. Titus made a motion to bid up to \$35,000.00 via the online auction for the purchase, Pearson seconded, the motion Passed By Roll Call Vote: Ayes - Swanson, Kutchera, Titus, Pearson, Johnson, Richards and Connealy. Nays- none. Road Committee member/Supervisor Pearson will place the bid.

<u>Stop Sign Program</u> Resolution 2025-04 was adopted upon motion by Kutchera, seconded by Titus. Passed By Roll Call Vote: Ayes – Swanson, Kutchera, Titus, Pearson, Johnson, Richards and Connealy. Nays – none.

CERTIFICATE OF COMPLETION – STATEWIDE UPGRADING EXISTING STOP SIGN LOCATIONS OF RURAL ROADS

Whereas: Burt County and State entered into an agreement "Statewide Upgrading Existing STOP Sign Locations of Rural Roads" (Program Agreement) for installation of STOP and/or STOP Ahead signing devices on county roads (the Project). Agreement Number BM2302 executed on October 3, 2023, and the purchase and installation of STOP and STOP Ahead sign devices. The project purchased the signs, and it is responsibility of the County to install all devices.

Burt County Economic Development Corp. (BCEDC): Cindy Chatt, Director Chatt reported that multiple Burt County marketing campaigns are underway. (i) liquid death marketing teams have given rights to all of their materials they've collected when in the area doing their own campaign; (ii) podcasts are working their way throughout the County, those can be viewed on the tourism website; (iii) billboards 'visit Burt County, it's closer than you think', 1- metro area, 1- waterloo area go up July 3rd and stay up for one month.

- FUND BALANCE: Chatt reported that she had turned in the application for the funding. APPLICATIONS: Currently there are more projects pledged than money available in this fund; therefore, at this time the board cannot accept any grant applications for the fund money.
