Delineators are present at the oncoming corners. Minor rail damage at the Southwest and Northeast corner. Minor gravel present on the deck. Concrete deck is worn with minor aggregate spalling and scaling. Deck has transverse cracks at 3-4 foot intervals. Superstructure paint is in fair condition with localized areas of heavy surface rust and minor loss. Girder 1 has minor damage to the low flange near Abutment 2. Minor debris in the superstructure. Deck forms are beginning to deteriorate. Substructure paint is in good condition with minor surface rust. Backwall planks at the top of the West end of Abutment 1 are deteriorated and letting soil through. Northeast wing has moderate loss of fill which is not into the roadway yet. Riprap placed at both embankments. Channel still has a poor approach angle at Abutment 1 and Southwest wing	may be joining Tribal on this bridge

Abutment concrete features moderate cracking throughout with heavier deterioration at the wing to backwall interface. Minor spalls below stringers. Bent pile and cap have light rust with no loss noted. Minor berms remain. Rock riprap in place at both berms. Minor brush growth in the channel.
