The Burt County Board of Supervisors met in regular session on Wednesday, January 11, 2023 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Oakland Independent (1-5-2023), upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: David Schold, Gary "Bird" Swanson, Paul Richards, Carl Pearson, Samuel M. Titus and Ted Connealy. Absent - Jeff Kutchera.

The meeting opened at 9:00 A.M. with the pledge of Allegiance. County Clerk Sarah Freidel informed the public that the Open Meeting Act is posted on the wall.

The first order of business was **reorganization**. County Clerk Freidel asked for nominations for Chairman of the Board. Pearson motioned to nominate David Schold, and Connealy seconded the motion. Richards moved that the nominations cease, seconded by Titus, and Schold was elected Chairman of the Board for 2023. By roll call vote. Ayes – Swanson, Richards, Pearson, Titus, Connealy and Schold. Nays – none. Absent- Kutchera. Motion passed. David Schold will be Chairman for 2023.

Burt County Offices/Employees:

- (a) Department updates: Beginning in 2023, the board would like to have office updates from Burt County Officials and Department Heads; the purpose of the meetings is to increase communication and transparency with all offices/departments. Officials and/or Department Heads were asked to have (2) two departments schedule themselves for the first meeting of each month, each office attending two meetings per year with the board.
- (b) 2023 salaries/wages: An across the board cost of living allocation is not being stated this year due to it being the start of the new Term. Resolution 2022-02 set salaries for Elected Officials; during 2022-23 Budget talks deputy wages and office clerical staff wages were also set for those Elected Officials office staff. The previously mentioned salaries/wages included consideration for cost of living for the said positions. The board decided upon a 5% cost of living for appointed department heads and for the hourly wage earners in for remaining offices; upon motion by Titus and Connealy, Passed By Roll Call Vote: Ayes- Swanson, Richards, Pearson, Titus, Connealy and Schold. Nays none. Absent- Kutchera. A worksheet with details of County Offices, positions and salaries/wages is on file; the new salaries/wages will be effective January 2023 payperiod.

Courthouse Security:

KC Bang, Emergency Manager reported that SEI would be installing security equipment mid-February 2023.
