## Minutes of the Burt County Board of Supervisors January 27, 2023

The Burt County Board of Supervisors met in regular session on Friday, January 27, 2023 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Oakland Independent (1-19-2023), upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Gary 'Bird' Swanson, Jeff Kutchera, Paul Richards, Sam Titus, Ted Connealy and David Schold. Absent – Carl Pearson. Supervisor Connealy had to leave the meeting before adjournment.

The meeting opened with the pledge of allegiance at 9:00 A.M. Chairman Schold informed the public that the Open Meeting Act was posted.

The agenda was approved; upon motion by Connealy, seconded by Swanson. By roll call vote: Ayes – Swanson, Kutchera, Richards, Titus, Connealy and Schold. Nays – none. Absent – Pearson.

The minutes of the 1/11/2023 Board of Supervisors meeting were approved; upon motion by Richards, seconded by Connealy. By roll call vote: Ayes - Swanson, Kutchera, Richards, Titus, Connealy and Schold. Nays - none. Absent - Pearson.

Claims: Upon review of claims, the board discovered *K-9 Handling costs* being logged in General payroll expenses. The County Board Discussed via phone with Sheriff Nick that these expenses were not disclosed upon creation of the K-9 fund nor during budget prep/approval. Sheriff Nick explained that 'standard procedure for having a K-9' includes paying a handler; Deputy Kautman will be paid 1 hr/day each month for handling. A payroll function line (1-0204 "K-9 Handling") was added to the Sheriff's General 651 office budget to track the added costs to the County. The board's concerns were due to this 'handling' expense not being explained or included when the Fund was approved and created. Payroll was approved for today; however, the handling costs can be moved to run through the K-9 fund in the future, the board will consider such change.

The claims for December in the amount of \$484,161.46 including \$160,479.25 for payroll, were read, audited, warrant drawn and checks generated on the respective funds on motion by Titus, seconded by Richards. By roll call vote: Ayes - Swanson, Kutchera, Richards, Titus, Connealy and Schold. Nays - none. Absent - Pearson. The following claims were approved:

## **ROADS**: Ann Chytka, Highway Superintendent

Burt County 2023 overlay Bids: (Bids were opened at the 1-11-2023 Supervisor's meeting, no action was taken at that time.) Ann recommended awarding Knife River. Richards made the motion to accept the bid from Knife River for all five (5) projects {C-11(362); C-11(364); C-11(437); C-11(442); C-11(445)} at a total cost of \$4,634,023.86, costs to be paid out in two budget years (FY22-23 and FY23-24). Kutchera seconded and the motion passed, By Roll Call Vote: Ayes – Swanson, Kutchera, Richards, Titus, Connealy and Schold. Nays – none. Absent – Pearson. The board asked Chytka to report to them the Engineering costs for the projects; Chytka reported back that the engineer fees will be around 3.5% of the total cost.

National Functional Classification Map of Burt County was reviewed, and Chairman Schold signed.
