Aerial Photography:

(previously discussed, see 2/8/2023 Minutes) Katie Hart, Burt County Assessor presented an example/information on 'growth found' per property adjustments/assessments. The board reviewed pricing and discussed companies/options for aerial photography via Eagleview and gWorks; Google Earth Pro was a third option mentioned today, so the board asked Katie to investigate that. No action was taken at this time.

K-9 Fund:

Participating in discussions with the board from Sheriff's Dept. were: Deputy Tristen Kautman, K-9 handler and Deputy Townsend. Discussions were brought up to address the use of K-9 funds necessary to support the needs of the K-9 program. Currently the K-9 fund is low and cannot support the monthly handling costs. Deputy Kautman and Townsend informed the board of the program's successes for the County and answered any questions/concerns of the board. The board expressed satisfaction with the program's performance but reiterated the need for continued funds to be sought out. March handling fees were paid via General Fund; future plans are still required on everyone's part in order to address support of the K-9 program and expenses.

BURT COUNTY, NEBRASKA RESOLUTION #2023-03

A RESOLUTION SETTING THE SCHEDULE OF FEES FOR ZONING AND SUBDIVISION TRANSACTIONS

WHEREAS, Section 1.16 of the Zoning Resolution of Burt County, Nebraska, provides that the Burt County Board of Supervisors shall establish a schedule of fees for various zoning transactions by a resolution; and

WHEREAS, the Burt County Board of Supervisors did discuss the Burt County Zoning Permit Fee Schedule at the March 15th, 2023 meeting

WHEREAS, the Burt County Board of Supervisors now believes that it is in the public interest to adopt said schedule of fees.

NOW, THEREFORE, BE IT RESOLVED by the Burt County Board of Supervisors that:

- 1. The following fee shall be added to the fee schedule:
 - A request for a one (1) year extension time for a Conditional Use Permit is 5% of the total cost of the original permit, due at the time of the extension request.
- 2. The schedule of fees shall be posted in the office of the Burt County Zoning Administrator and on the Burt County Website, and may be altered or amended only by the Burt County Board of Supervisors.
- 3. The schedule of fees shall be effective on and after April 1, 2023. WHEREUPON, the Resolution was declared passed by the Burt County Board of

Supervisors on the 28th day of March, 2023, at Tekamah, Nebraska.

Penalty for not obtaining a permit before project begins is 5 times the amount of the fee, plus the cost of the original fee.

(b) BURT COUNTY SOLAR - 'Conditional Use Permit' EXTENSION REQUEST Present speaking: Michel Knapp with Sandhills Energy. Sandhills Energy came before the board to request a two-year extension for the CUP they currently have for Burt County Solar project. Knapp reminded the board that approximately a year ago the road agreements and decommissioning agreement for the project were solidified; however, since that time the project had been waiting for grid analysis. Mr. Knapp reports the project has now reached the next steps of continuance with *Southwest* Power Pool, and the project is officially 'a go'. He explained the schedule and announced that they anticipate the Solar Farm coming online late 2025. Having a firm schedule in place, they are now asking the Burt County Board to grant a twoyear extension for their CUP. Supervisor Richards made a motion to approve a twoyear extension (for 2023-2024 and for 2024-2025) for Burt County Solar project CUP; Kutchera seconded. Motion passed By Roll Call Vote: Ayes - Swanson, Kutchera, Richards, Pearson, Titus, Connealy and Schold. Nays - none. Per the newly updated zoning fee schedule; Sandhills agreed to pay the 5% per year extension fees (\$1,000.00 for 2023-2024 and \$1,000.00 for 2024-2025).
