OFFICE UPDATES (2): (1) Treasurer - Robin Olson (2) District Court - Michele Quick

Courtroom Equipment

Michele Quick, District Court Clerk reported that updates to Courtroom equipment is complete. The equipment costs were paid via a State Grant applied for by the (AOCP) Admin Office of Courts & Probation; now the ownership of the equipment will transfer to Burt County. Chairman Schold signed the transfer paperwork.

Demo Grant Applications:

Burt County Economic Development submitted a demolition grant application, BCEDC board had reviewed the request and recommended their approval for demolition grant for Steve Devening (1504 E St., Tekamah), \$3,6000.00 (50% low bid). Burt County Board approve the demo grant (Fund 0900), upon motion by Kutchera, seconded by Richards. By roll call vote: Ayes – Swanson, Kutchera, Richards, Pearson, Titus, Connealy and Schold. Nays – none.

Public Transit Program Proposal:

David Branch, Cuming County Economic Development and Tyler Toline, CEO of Franciscan Healthcare presented a proposal for Public Transit Services to be offered via a joint venture between Burt County and communities and Cuming County and their communities and Franciscan Healthcare. Citizens utilizing the services will pay a small useage fee based off duration/distance; rides will be provided on a first come first serve basis. Franciscan Healthcare would operate the entire program; i.e. vehicle acquisitions and maintenance, staffing, scheduling, monthly/annual grant paperwork requirements and comply with all regulations thereof. Funding will come from three sources: Federal sources (Federal Transit Admin), State Sources (NE Dept. of Transportation), and Local matches (Burt County, Cuming County and Cities/Villages within both Counties); local match covers 25% of operating costs and 10% of capital and non-operating costs, the local match is required to secure the Grant funding. Mr. Branch will return to a future Burt County Board meeting with final numbers for participation in the program at a later date; he anticipates Burt County's portion to be \$15,000.00-\$20,000.00 and requested a two-year commitment. No action today.

City/Village Building Permits:

Katie Hart, Burt County Assessor asked to discuss an issue her office is having regarding the County's Cities/Villages; there is a lack of building permits being turned in from the County's Cities/Villages. The issue is problematic in that if permits are not obtained and/or turned in to the County, the result is a loss of growth and value for all taxing entities affected. Discussion and Resolution: Communication will be drafted explaining the necessity of the permits; Katie will present to all five (5) City Councils/Village Boards of Burt County, County Board members offered to attend the meetings with Hart within their respective districts.

ROADS: Present for discussions: Andy Braniff, Road Employee
(a) Road Committee Report: Tool Truck engine blew up ('08 Dodge 5500); Board advised Braniff collect cost comparisons for new engine -vs- new cab/chassis.
(b) Lyons Shed – spray insulation bids: The board advised Braniff to bring back cost comparisons for full insulation of exterior walls -vs- putting up walls to create bays in order to insulate less area.

(c) State Stop Sign Program – Resolution 2023-12

Supervisor Pearson made a motion to sign the Contract and Resolution for the Stop Sign Program, Richards seconded. Approved By Roll Call Vote: Ayes - Swanson, Kutchera, Richards, Pearson, Titus, Connealy and Schold. Nays - none.
