# Minutes of the Burt County Board of Supervisors November 28, 2023

TEKAMAH NE 68061

The Burt County Board of Supervisors met in regular session on Tuesday, November 28, 2023 in the Boardroom of the Burt County Courthouse in Tekamah, Nebraska, pursuant to adjournment of their last meeting. Notice of the meeting was given in advance thereof by Publication in the Oakland Independent (11-23-2023), upon a 1st floor bulletin board within the courthouse and on the County's Website. A copy of the proof of publication is on file in the office of the County Clerk. The following members were present: Gary 'Bird' Swanson, Jeff Kutchera, Paul Richards, Carl Pearson, Sam Titus and Ted Connealy. Absent - David Schold.

The meeting opened with the pledge of allegiance at 9:00 A.M. Vice-Chairman Ted Connealy informed the public that the Open Meeting Act was posted.

# Tekamah Joint Airport Zoning - Invoice:

Mark VanDerHart was present to submit and explain an annual bill from the Tekamah Joint Aiport Zoning Commission. He explained: their board is required by State Statute to have two regular meetings per year; each meeting costing approx. \$150.00 (\$100 for secretary fees and \$50 for publication fees). The commission is not directly funded by any tax revenues; so that amount will be divided among the four political subdivisions that appoint representatives to serve on their board: (1) Tekamah City, (2) Burt County, (3) Washington County and (4) Harrison County, IA. This would make each subdivision responsible for \$75.00/year. Along with two annual meetings, any special meeting called for permitting would also be billed to the corresponding Entity where the permit applies. This funding process is a new process that has been established; after further clarification with VanDerHart, the Supervisors agreed to advise Clerk Freidel to set up a revenue and expenditure line in the County's budget in order to track Burt County's portion of any meeting expenses/zoning revenue. CODES: EXPENDITURES:(zoning) 2-4407 & REVENUE: 325.09

Resolution 2023-17

Signing of the Year-End Certification of County Highway Superintendent 2023

Whereas: State of Nebraska Statutes, sections 39-2302, and 39-2501 through 39-2505 details the requirements that must be met in order for a county to qualify for an annual Incentive Payment; and

Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each county must annually certify (by December 31st each year) the appointment(s) of the County Highway Superintendent(s) to the NDOT using the Year-End Certification of County Highway Superintendent form; and

Whereas: The NDOT requires that such certification shall also include a copy of the documentation of the county highway superintendent's appointment; i.e. meeting minutes showing the appointment of the County Highway Superintendent by their name as it appears on their License (if applicable), their License Number (if applicable), and Class of License (if applicable), the type of appointment, i.e., employed or under contract (consultant, or interlocal agreement with another county and/or incorporated municipality), and the beginning date of the appointment; and

Whereas: The NDOT also requires that such Year-End Certification of County Highway Superintendent form shall be signed by the County Board Chairperson and shall include a copy of a resolution of the County Board authorizing the signing of the Year-End Certification of County Highway Superintendent form by the County Board Chairperson.

Be it resolved that the County Board Chairperson of Burt County is hereby authorized to sign the attached Year-End Certification of County Highway Superintendent form(s).
