Notice is hereby given that on Tuesday the 12th day of May 2026, at the usual polling places in the election precincts of Burt County, Nebraska, an election will be held for nominating, or in some cases electing, candidates to various offices. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices.

Nonpartisan voters may vote for federal races of the party candidates of their choice. State law allows state parties to extend that beyond federal races. The Democratic Party and Libertarian Party have opened to nonpartisan voters. The Republican Party and Legal Marijuana NOW Party only allows nonpartisan voters to vote in U.S. Senate and House of Representatives races. **A nonpartisan registered voter must ask for this special ballot.**
